Terms & Conditions

- Contestants must be residents of <u>Chua Chu Kang Town</u> (Chua Chu Kang GRC and Hong Kah North SMC).
- 2. Photograph(s) submitted must be original and show a location in Chua Chu Kang Town.
- 3. Each photograph entry must be submitted digitally in landscape JPEG format, be at least 300dpi and no larger than 5MB in size.
- 4. All entries must be submitted to CCK Town Council by **16 October 2022**, **2359** hours via the online Contest form or by email to corpcomms@ccktc.org.sg.
- 5. Entries must include the contestant's
 - Name
 - Mobile number
 - Address including postal code and the estate in CCK Town (eg Bukit Gombak, Brickland, Chua Chu Kang, Keat Hong or Hong Kah North) and
 - Email

The location in CCK Town shown in the photo must also be indicated.

- 6. Late entries will not be accepted and shall be disqualified.
- Photograph(s) should not include any objectionable content. The organiser shall have sole and absolute discretion to decide whether content is objectionable. Photograph(s) deemed to be objectionable shall be disqualified.
- 8. The organiser reserves the sole and absolute discretion to exclude or disqualify any submission(s) and/or entry from the contest.
- 9. Photographs that are intended to be used for any kind of commercial purpose must not be submitted.
- 10. Digital manipulation that distorts the reality of the photographs is not allowed. Only basic enhancements, such as sharpening, contrast adjustment, conversion of colour images to be black and white, are allowed.
- 11. By participating in this contest, the contestant warrants that he/she has not trespassed into any areas closed to the public and has put the welfare of the subject (if applicable) foremost and has not obtained the photograph via any unethical means.
- 12. Winners may be interviewed by the organiser and/or the media. All winners consent to public disclosure of their names and the results of the contest.
- 13. Upon submission, the contestant gives CCK Town Council (and their employees, representatives, agents, and those they work with) an irrevocable, royalty-free and non-exclusive worldwide license to:
 - a. use, host, store, reproduce, modify, create derivative works of the photographs submitted (such as those resulting from translations or adaptations); and
 - b. communicate, publish, publicly display and distribute, such photographs
 - in any format or medium now known or later developed, including digital media, software-based or online formats on the internet and/or social media, for the Chua Chu Kang Town Council's publicity, promotional and/or marketing purposes.
- 14. Participation in the contest will require the collection, use, processing, and disclosure of contestant's personal data (such as the name mobile number and contact details). By participating in the contest, contestants are deemed to have consented to CCK Town Council's collection, use and disclosure of personal data (to the Town Council's service providers where required) for the purposes of conducting and administering the contest to fulfil its obligations under these Terms and Conditions, in accordance with the Personal Data Protection Act 2012.
